During the 2023 tax year, Bikes for the World (BFW) enlisted the participation and assistance of some 60 U.S. community service individual volunteers to collect 11,915 used bicycles and donate them to program partners in 10 countries: The U.S. El Salvador, Costa Rica, Barbados, Ghana, Burkina Faso, Madagascar, Rwanda, Sierra Leone, and Kenya. Bicycles donated abroad provided access to employment, skills training, education, and health care. Bicycles donated in the United States provided transportation to low-income workers, and training and recreational opportunities for at-risk youth. BFW's volunteer-based efforts provide educational and rewarding community service opportunities to volunteers of all ages, enabling many to meet service requirements for high school graduation, Boy Scout and Girl Scout Eagle and Gold Ranks, Bar Mitzvah Service, and more.

The director reviews incoming proposals in line with the proposal guidelines and the mission of Bikes for the World. Communication takes place primarily via email and phone calls. Wherever feasible, we enlist an impartial third party volunteer to visit overseas proponents' sites and provide additional information. Generally we do not do our own site visits. All donations are in-kind.

The "amount" to be donated initially consists of the contents of a 40' container holding approximately 500 used bicycles, plus used and new spare bicycle parts, and calculated based on the average value of a donated bike recorded on receipt by volunteers and staff, to be about \$82.52, or \$41,260. Monitoring is done via reports, email and phone communication, and the periodic visit by volunteer or contracted third parties, or by a staff member.
